Intended Use, Intended User And Scope Of The Appraisal Assignment.¹

The purpose and intended use of this appraisal was to provide an independent professional opinion of the fair cash value of the tangible personal property contained at the dental offices of

M.D., M.S., LLC for use in ad valorem tax assessment. The scope of the appraisal included a physical inspection, inventory, research and the preparation of this narrative appraisal report.

Factual Background on Assessment

Massachusetts General Laws, Chapter 59, § 38 states, "the assessors of each city and town shall at the time appointed therefor make a *fair cash valuation* of all the estate; real and personal, subject to taxation therein, and such determination shall be the assessed valuation of such estate."

Upon the completion of each ad valorem valuation, the assessor or his agent is required by statute to subscribe under penalty of perjury that "*the real and personal estate contained in said [valuation], and assessed upon each person in said [valuation], is a full and accurate assessment upon all the property of each person, liable to taxation, at its full and fair cash value, according to our best knowledge and belief.*" [Mass Gen. Laws Chapter 59, § 52].

The duty of assessors is to assess property at its "fair cash valuation."² The assessor's oath of office includes an oath that he "*will neither overvalue nor undervalue any property subject to taxation.*" Mass General Laws, Chapter 41, § 29. The assessor is to subscribe, at the end of a valuation list, "under the penalties of perjury," a statement that each assessment of property is made "at its full and fair cash value, according to our best knowledge and belief."³

Definition of Fair Cash Value

Chapter 59, § 21c , Section 21C. (a) Whenever used in the text of this section, the following words and terms shall have the following meanings:— "Full and fair cash valuation", the fair cash value of all real estate and personal property as defined in this chapter, as certified by the commissioner.

The terms "fair cash valuation," "full and fair cash value," and "fair cash value" are used interchangeably throughout the statutes and cases relating to tax assessment of personal property. All three terms have the same meaning, defined as:



The standard of valuation of property subject to local taxation is fair cash value. This means fair market value, which is the price an owner willing but not under compulsion to sell ought to receive from one willing but not under compulsion to buy. It means the highest price that a normal purchaser not under peculiar compulsion will pay at the time, and cannot exceed the sum which the owner after reasonable effort could obtain for his property. A valuation limited to what the property is worth to the purchaser is not market value. Nor is the value of the company's property to it or to the owners of its capital stock to be included. The fair cash value is the value the property would have had on January 1 of any taxable year in the hands of any owner, including the present owner. In determining fair cash value, the value of such property for any special purpose together with its value for all purposes for which it is reasonably

adapted may be shown.⁴

Ad valorem property taxes are levied on both real or personal property by the City of Ad valorem means a tax on goods or property expressed as a percentage of the assessed value.

Real property includes real estate and capital improvements that are classified as fixtures, which is something permanently attached to the real estate where removal would cause damage. Hence, capital improvements of property generally increase property taxes. Personal property includes all assets that are not realty.

Property Subject to Taxation

Massachusetts General Laws, Chapter 59, § 2 states, "all property, real and personal, situated within the commonwealth, and all personal property of the inhabitants of the commonwealth wherever situated, unless expressly exempt, shall be subject to taxation."

This means that things "affixed thereto," or fixtures are categorized as real property and not personal property. Black's Law Dictionary defines a fixture as "personal property that is attached to land or a building and that is regarded as an irremovable part of the real property."⁵ A fixture is distinct from a trade fixture which Black's Law Dictionary defines as "removable personal property

that a tenant attaches to leased land for business purposes, such as a display counter. Despite its name, a trade fixture is not usually treated as a fixture, i.e. as irremovable." *Id.*; see also *Chapman v. Katz*, 65 Mass. App. Ct. 826, 830-31 (2006) (finding trade fixture to be personal property and not an improvement to real property). Therefore, property affixed to the building is to be considered real property and not considered in the tax assessment of the separate personal property.

There is a common law of fixtures which defines personal property as movable items that are not permanently affixed to, or part of the real estate. Personal property is commonly known as "personalty" or "chattels". Ad valorem assessment of personal property applies to trade fixtures but not to fixtures.

The common law test for fixtures considers physical affixation, suitability to the real estate, and the intent of the parties. The distinction between real property and tangible personal property, sometimes called the law of fixtures, is an old common law doctrine. There may be a question of what property a tenant can remove when the lease ends, or whether a creditor with a security interest can take possession of a particular piece of equipment. If the property causes injury, the same common law test may be relevant to determining who may be sued, whether insurance applies, or the applicable statute of limitations.

In the ad valorem context, this common law test will often apply or at least inform the analysis of whether a piece of property has become part of the real estate. It is a subjective, fact-sensitive analysis, and the correct characterization for tax purposes can be debatable. The three elements of the common law fixture test are as follows:

1. The physical nature of the property's attachment to the real estate. This factor is fundamentally a question of engineering. It considers the mechanics of how the property has been connected to the real estate, nails, bolts, wiring, ductwork, etc. It also considers the potential injury to the real estate if the property was removed.
2. The adaption to and necessity for the purpose for which the premises are devoted. This factor weighs the relevance of the property to the real estate on which it may be affixed. If the property is specifically suited to the real estate, that weighs in favor of treating the property as a fixture.
3. Whether it was intended that the item be considered to be part of the realty. Where the other two factors consider the physical nature of the potential fixture and the parcel to which it may be affixed, this third factor considers the intent of the party or parties involved in the potential affixation. It often takes into consideration the terms of the agreement between the parties.

It is sometimes said that the law of fixtures test is fundamentally a question of intent, and that the test two factors are objective manifestations of the parties' intent.⁷ The purpose of this appraisal was to provide an independent professional opinion of the personal property owned by the dental practice.

The City of [redacted] Assessor Record lists 25 items of personal property. The list is inaccurate and in some instances, references fixtures which are part of the building's infrastructure. The inaccurate listing includes the following: (1) four autoclaves (there is one autoclave); (2) lists a copy machine and a print/copy/fax machine (there is only a print/copy/fax machine); (3) lists two dental curing lights (there were none); (4) lists a vague description of computer system, computer workstation, and a second computer system (there are five personal or desk-top style computers and monitors); (5) lists four dental cabinets @ \$800 each (there are three large built-in dental cabinets and one small built-in cabinet); (6) lists a Dental Vacuum Water, Dental Vacuum, Dental Ultra Cam (the Vacuum water and air system is in the basement, connected to the four separate leased dental offices in the building).

In the 1970s, dentists [redacted], [redacted] ophthalmologist, [redacted] and four other dentists [redacted] built the medical office complex at [redacted]. Children of the founding builders [redacted] and [redacted] still occupy the complex. The group of six dentists custom built the building to house the six dentist practices and the [redacted] ophthalmology practice.

The custom build-out included installing medical cabinets into the structure of the dental rental units and installing a common vacuum pumping system, dental drains, and water filter systems. These items became a part of the real property as fixtures owned by [redacted] Octors Park Trust.

Dr. [redacted] MD occupied the subject rental unit from the mid-1970s until approximately 2010. Dr. [redacted] acquired the dental practice and all equipment of [redacted] n, DMD in 2010. Some of the assets acquired from Dr. [redacted] were originally acquired by Dr. [redacted] in 1980, approximately 35 years ago. The built-in cabinets and plumbing and vacuum system were fixtures, meeting the three criteria of the law of fixtures. They are utilized by the tenant as part of the realty. They should be assessed as part of the office building.

Some items, such as autoclaves, curing lights, and an X-Ray processing system which were obsolete are no longer in the office complex. In addition, the compressor, dental vacuum system and vacuum water system are located in the basement and are fixtures, shared and utilized by the six dental practices. The computers utilized fifteen years ago, listed as acquired in 2000 have been replaced. The items on the City Assessor list that are no longer at the dental practice or which are fixtures amounted to approximately \$27,000.

We attempted to match the City Assessor Record with the physical inventory. Many items listed are no longer present. Therefore, we used the physical inventory as the most accurate listing of the taxable personal property owned by the Dental Practice of [redacted] MD, M.S., LLC.

Assumptions and Limiting Conditions

- 1) An appraisal is an unbiased estimate of the value of a property reached through an analysis of that property and of data from the marketplace. The major assumptions and limiting conditions of this appraisal are as follows:

- 2) We assumed a good and marketable title and a continued utilization of the items in connection with a similar dental practice.
- 3) Information, estimates and opinions furnished to, and used by us, were obtained from a great number of sources considered to be reliable. We reserve the right to review any new evidence that might affect the value of the subject property.
- 4) We assumed that the equipment was operational unless otherwise noted. We did not experiment or test the equipment and therefore cannot warrant the condition or reliability beyond the comments of fair, good or new condition.
- 5) This appraisal has been made and written for the specific purpose described. Use for any other purpose is unintended and may be misleading.
- 6) We are not required to give testimony, appear in court or perform any additional work to support the conclusions of this report except under the terms of our engagement letter.
- 7) The City of [redacted] our client, may distribute copies of the appraisal in its entirety to such third parties as it may select.

Method of Valuation

The Market Comparison Approach was used in the research and in the value opinions. This method relates a market value observation reflecting supply and demand, and the value as perceived in the market. Generally, it is understood that the market has several tiers, including retail, wholesale, distributor, and public auction. In the Market Comparison Approach, sales of closely comparable items were researched. A number of characteristics, in addition to physical properties, were examined, including size, age, design, and condition, according to the criteria accepted and used in the market for the property. Other considerations in defining a market layer are the number of buyers, the quantity and quality of goods available, the geographical location, and methods of marketing.

To make this determination, courts have found that actual sales of comparable property are very strong evidence of fair market value for assessment purposes. *First Nat'l Stores, Inc. v. Bd. of Assessors of Somerville*, 358 Mass. 554, 560 (1971). Evidence of comparable market sales and capitalized net earnings may constitute legitimate methods for determining fair cash value of property for property tax purposes. *Montauk Elec. Co., v. Bd. of Assessors of Whitman*, 390 Mass. 847, 850 (1984).

Effective Date of the Appraisal: The effective date of this valuation is January 1, 2015.

Description of the Assets

The dental practice occupies [redacted] Massachusetts. The equipment consists of general dental equipment.
