In Memoriam



Marion Fantucchio, age 85, a lifelong resident of Quincy, passed away on Friday July 27, 2018 after a brief illness. Marion had a long and distinguished career with the city of Quincy. She joined the staff of the assessor's office following her graduation from Quincy High School and advanced to the positions of Chief Assessor, and Chairperson of the Board of Assessors, which she held from 1991 until her retirement in 2011. Following her retirement, Marion continued her association with the assessor's office until her death. Marion was also very active in related professional organizations. She was a member of the Massachusetts Association of Assessing Officers, serving as Secretary for several years. In addition, she participated in the Northeastern Regional Association of Assessing Officers. She was also generous with her time, participating in charitable events.

2018 Maine Sherry Vermilya Award Presented to Cathleen Jamison

Cathleen Jamison is the Assessor for the Town of Brunswick, Maine. She is a former president of the local chapter of the IAAO and has been very active on committees and in the recertification of property values in her state.

2018 Maryland Sherry Vermilya Award Presented to Denise Fuhrman

Denise has worked for the State of Maryland Department of Assessments and Taxation since 2004 and is currently an Assessor III with the agency. She is currently the President of the Maryland Association of Assessing Officers and has also served as Vice President and board member.

Eric began his assessing career in the Town of Chelmsford and has been the assessor for the Town of Weston since 2001. He served on the executive board and as President of the Middlesex County Association of Assessing Officers. 2018 New Hampshire Sherry Vermilya Award Presented to Kris McAllister

Kris works as an assessor/ supervisor for the 'Tri-Towns' of New London, Newbury and Sunapee. She is a Certified New Hampshire Assessor and a Certified New Hampshire Department of Revenue Assessor Supervisor. She has been an active member of the New Hampshire Association of Assessing Officers for many years and often attends legislative hearings.

2018 New Jersey Sherry Vermilya Award Presented to Scott Holzhauer

Scott is currently the assessor in Bergen, Morris and Sussex counties. He began his career by forming an appraisal firm. In 1998, he also became a tax assessor. In 2001, he left the firm and began his career as a full time tax assessor. He currently serves several townships while also volunteering tirelessly for his profession. He has been AMANJ President, two-term Tri-county Vice President, Sussex County Assessor Association President, executive board member and assessor in three counties.

2018 New York Sherry Vermilya Award Presented to Denis Ketchem

Dennis is currently the assessor in three towns: Montgomery, Mount Hope and Forestburgh. He was the President for the New York Assessors Association in 2015/2016 and is currently a trustee with the New York Institute of Assessing Officers. He has also held the position of treasurer for the Orange County Assessors Association for many years.

2018 Rhode Island Sherry Vermilya Award Presented to Christine Brochu

Christine opened her own appraisal business in 2006. In 2011 she became the assessor for the Town of Hopkinton. She has also been the assessor for the Town of West Warwick and is currently the assessor for Jamestown. She served on the 2013 and 2019 NRAAO/ RIAAO conference committees. She has served on the executive board and has been President of the Rhode Island Association of Assessing Officers. While President, she oversaw completion of the Rhode Island Assessors Handbook.



2018 Vermont Sherry Vermilya Award Presented to Michelle Wilson



Michelle currently serves as the Head of the Assessing Department for the Town of Hartford Vermont. She is the Vermont Assessors and Listers Association representative to the IAAO, has been the Operations Chief for State Property Valuation and Review and has operated her own appraisal business. Michelle also developed and implemented the Vermont certification program for Municipal Assessing Officers and designed and organized the current educational course program for Vermont designation.

Catherine "Kay" Pardee Award

Marsha's career started through the business program at Stonington High School. She was one of a select core business student group. Upon graduation the participating students were pretty sure to get employment. Marsha graduated and was asked to report to Town Hall. She started work full-time in the Selectman's Office on July 7, 1970. In early fall of 1970 she went to the Assessor's Office as an Assessor's Clerk. In the Stonington Assessor's Office the clerks were involved "in everything". When Marsha started in the Assessor's Office in 1970, it was unusual for clerical staff to go for courses at the Assessors School at the University of Connecticut. In 1976, Marsha attended her first Assessors School and took the first of three CCMA courses. She passed the CCMA examination in late 1977 and became the youngest person to have earned a CCMA.

1978, she became a Sales Assessment Ratio Field Representative with the Department of Revenue Services of the State of Connecticut. In 1979 Marsha was promoted from the sales ratio program to become the first woman on the Board of Assessment Advisors. At the time Marsha began working for the State of Connecticut she also began to go the Community College of Rhode Island in pursuit of an Associate in Science Degree in Business. So while working full time, she commuted a total of 126 miles to and from work in Hartford, cared for her son who had cystic fibrosis and went to community college at night to pursue a degree. She earned her Associate's Degree in 1987 and her Bachelor's Degree in 1997.

During her time with the State, Marsha began teaching course 1A at the Assessors School at the University of Connecticut. In 2000, Marsha began serving as a Moderator in the workshop program at the Assessors School. In 1996, Marsha returned to the Assessor's Office of the Town of Stonington as the Assessor for the town.

Marsha has been very active in the Connecticut Association of Assessing Officers and the International Association of Assessing Officers. She has served on numerous committees in both groups. Of special note, Marsha was elected to the Executive Board of the International Association of Assessing Officers and served from 2000 to 2002. She served as President of CAAO in 2005. In 1981, she earned the CAAO Essay Award. In 1994, Marsha was given the CAAO Distinguished Service Award. In 1998, she was given the Continuing Service Award. And, in 1999, she was honored as the CAAO Assessor of the Year. In the Town of Stonington, in 2005, Marsha was asked to serve as a member of the Board of Directors for the Stonington Historical Society.

Marsha's efforts and contributions to the assessment community, to State government, and to local government have been wonderful achievements and we all have benefited from Marsha's hard work and dedication to a job well done.

April 29, 2018 Board of Directors Meeting Highlights

SECRETARY REPORT: Gus was not in attendance. Some amendments were made to the report and it was approved.

PRESIDENT REPORT: Ginny thanked Paul Lesperance for his service as Treasurer and announced Larry LaBarbera will be nominated to replace Paul. She also said Gus's health is not well and Bryan Levenson will be nominated to replace Gus as Secretary.

TREASURER REPORT: Paul submitted his final report as Treasurer. He described the details of the report and some questions from board members were asked and answered.

COMMITTEE REPORTS:

MEMBERSHIP- Betsy noted the total membership numbers are down about 100 members. Discussion ensued brainstorming ideas on how to increase membership. With permission from the Rhode Island committee, a vote passed for the "2 for 1" membership rate to continue next year.

EDUCATION- Les noted all 2018 conference courses were approved by member states except for NJ for the personal property sessions which don't apply in that state.

BUDGET ADVISORY- Tony reported the transition from Paul to Larry is going smoothly. This summer, Paul will give Larry a check with which to open a new account. Ginny again thanked Paul for his years of service and also stated an audit should be done within the next year.

AWARDS- Kathy reported nine states participated in the Sherry Vermilya Awards. The Pardee and Prendergast awards will be announced at Wednesday's banquet.

SCHOLARSHIP- Viviane said all five alternates were utilizing the scholarships this year. Her written report was submitted. Discussion ensued regarding who should be eligible for scholarship, how many scholarships should be given and if the scholarship should only cover registration, or if it can be used for hotel/ travel expense. A vote passed to keep the same process and to have 10 scholarships for next year.

BYLAWS/INFRASTRUCTURE- No report was given.

NEWSLETTER- Article submissions can be sent to Jessica. If states want to send in their local newsletters, they can send it to Chris to be posted on the website.

WEBSITE- Chris reported the site gets about 1200 hits a month. Please send content to him for posting. Discussion ensued whether to post conference course documents to the site or not. There were arguments for and against.

CONFERENCE ADVISORY- A site visit was done in North Conway, NH. Both hotels visited had pros and cons, but the location has been approved.

OTHER BUSINESS:

John O'Connor, Legal Counsel, announced that after 14 years he is retiring from the position.
